 - b. Automobile liability insurance for limit of not less than \$1,000,000 per accident.

The HCDA and State of Hawaii shall be named as additional insured.

c. Professional liability insurance for limit of not less than \$1,000,000 per claim and \$2,000,000 annual aggregate.

If a firm is not able to provide the above insurance certificates at this time, a letter from an insurance company stating, if the firm is selected, they will insure the firm for the insurance policies and the amount of minimum coverage required above, will be accepted as proof of insurance.

4. Any other pertinent information.

A list of past projects or services provided to the HCDA and experience with State of Hawaii projects will be helpful for the HCDA to determine qualifications of the applicant. If you wish to be considered for multiple categories indicate which disciplines you want to be considered for in your letter of interest.

Selection Criteria

Selection of professionals will be made in accordance with Section 103D-304, HRS and Section 3-122 Subchapter 7, Hawaii Administrative Rules, as amended. The selection criteria employed in descending order of importance shall be:

- 1. Experience and professional qualifications relevant to the project type;
- 2. Past performance on projects of similar scope for public agencies or private industry, including corrective actions and other responses to notices of deficiencies;
- 3. Capacity to accomplish the work in the required time; and
- 4. Any additional criteria determined in writing by the selection committee to be relevant or necessary.

Campaign Contributions by State and County Contractors

Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or County government contractors during the term of the contract if the contractors are paid with funds appropriated by a legislative body.
