
Dear Sir or Madam:

This letter is a request for your authorization of the market sale of our home located at 1009 Kapiolani Blvd., unit 609 at the Pacifica Honolulu. We fully understand that our unit is subject to a five-year buy-back period, during which the HCDA has the first option to purchase the unit, and that we are still within the regulated term of five years. It is with much regret to inform the Board of HCDA that after nine years of marriage, we are now in the process of obtaining a divorce, which has necessitated the sale of our home prior to the expiration of this regulated period.
