MINUTES

I. CALL TO ORDER/ROLL CALL

The Hawaii Community Development Authority ("Authority" or "Board"), a body corporate and a public instrumentality of the State of Hawaii met virtually (utilizing the state-supported Zoom Meeting platform) for a meeting on December 1, 2021.

Chairperson Susan Todani called the December 1, 2021, HCDA General Authority meeting to order at 10:45 a.m. Chair Todani stated Executive Director Neupane will go over the meeting protocols.

Acknowledgement that the Meeting is Being Convened Virtually

Executive Director Deepak Neupane reiterated the wording contained in the Meeting Agenda regarding the guidelines and directives provided by the Governor's Emergency Proclamation Statutes to the extend necessary to enable public boards and commission to conduct business without holding meetings open to the public.
