SUBJECT: 2022 FUNDING CYCLE and 4% LIHTC Applications

The Hawaii Housing Finance and Development Corporation (HHFDC) will be commencing with its 2022 Funding Cycle shortly for the following programs:

- Dwelling Unit Revolving Fund (DURF) Program
- Hula Mae Multi-Family (HMMF) Revenue Bond Program
- Low-Income Housing Tax Credit (4% and 9% LIHTC) Programs
- Rental Housing Revolving Fund (RHRF) Program

We would also like to inform you that 4% LIHTC application requests will no longer be accepted year-round and will only be accepted during the official funding cycle. For more information on this and other changes, we ask that you carefully review the 2022 Consolidated Application and the 2022-2023 Qualified Allocation Plan to familiarize yourself with the new requirements.
