ICT ACCESS

To view the meeting and provide live oral testimony, please use the Zoom link above. As an attendee, your microphone will be automatically muted. If Chairperson asks for public testimony, you may use the Raise Hand button found on your Zoom screen to indicate that you wish to testimony. When recognized by the Chairperson, please unmute your microphone before speaking and mute your microphone after you have finished speaking.

TELEPHONE ACCESS

If you do not have ICT access, you may get audio-only access by calling the Telephone Number listed above.

Upon dialing the number, you will be prompted to enter the Meeting ID that is listed next to the Telephone Number above. After entering the Meeting ID, you will be asked to either enter your panelist number or wait to be admitted into the meeting. You will not have a panelist number. Please wait until you are admitted into the meeting.

When the Chairperson asks for public testimony, you may indicate you want to testify by using the "raise your hand" image in Zoom. When recognized by the Chairperson, you may unmute yourself by pressing "*" and then "6" on your telephone. A voice prompt will let you know that you are unmuted. Once you are finished speaking, please enter "*" and then "6" again to mute yourself. Each testifier will be requested to limit time to two minutes of testimony per agenda item.

LOSS OF CONNECTIVITY

In the event of a loss of ICT connectivity, the meeting will be recessed for a period not to exceed thirty minutes to restore connectivity with all Task Force members and the public in-person access location noted above.
