LEGAL BASIS AND PURPOSE

The hearing on Development Permit Number KAK 12-075 was held in accordance with Act 61, Session Law of Hawaii 2014, Subchapter 3 of Hawaii Administrative Rules Chapter 219 of Title 15, and the vested HAR Chapter 15-22.

The following description was provided: Pursuant to Hawaii Administrative Rule, Section15-219-98 petitioner OMPR requests that the HCDA amend Development Permit No. KAK 12-075 by waiving or permanently suspending the requirement of Hawaii Administrative Rule, Section 15-217-55(k)(2) Symphony Honolulu project and that such waiver or permanent suspension be retroactive from April 5, 2015.
