II. APPROVAL OF MINUTES

1. General Regular Meeting of September 7, 2016.

III. REPORT OF THE EXECUTIVE DIRECTOR

Interim Executive Director, Aedward Los Banos provided a brief report highlighting a revision in the agenda language. Per an appeal with the Office of Information Practices, the language to the agenda will now specify the content that will be reported in the Executive Director's Report. Mr. Los Banos mentioned the financial report is also included in the board packet for the month ending September 2016.

KALAELOA UPDATE

Mr. Los Banos encouraged board members to review the Kalaeloa report provided in the board packet as it includes an update and summary of the Kalaeloa Landowner Summit that was held October 18, 2016. After discussions with Sandia Laboratories, there will be an updated draft report on the potential energy solutions for Kalaeloa that includes microgrid technology.

Mr. Los Banos clarified for Member Capelouto that the infrastructure matters in Kalaeloa pertain to the Enterprise Energy Corridor Project and that HCDA is pending Hawaiian Electric Company's final comments on the design of the energy corridor.

There were no further questions, comments or discussion by board members and the public.

1. <u>Discussion/Decision Making</u>: Shall the Authority Make a Selection of a New Executive Director for the Hawaii Community Development Authority?

Chair Whalen noted the Authority's task force consists of members Mary Pat Waterhouse, Amy Luersen, Jason Okuhama and Chair Whalen and also community members Jan Yokota, former executive director for HCDA, Maeda Timson, a former board member and resident of Kalaeloa, and Sharon Moriwaki, resident of Kakaako who organized the Kakaako United organization. executive session. All staff and public members were excused. Attorney General Lori Sunakoda and Mike Wong, and Erinn Tomlinson of Bishop and Company, the search consultant that the Authority hired to assist with the Executive Director recruitment will also participate in the executive session.

Member Golojuch motioned for the board to convene in executive session pursuant to Hawaii Revised Statutes Section 92-5 (a) (2). Member Luersen seconded the motion. Chair Whalen conducted a voice vote. All members unanimously approved entering into executive session.

Chair Whalen reconvened the meeting at 1:00 p.m.
