I am Sharon Moriwaki, a resident of Kaka'ako and president and volunteer of Kaka'ako United (KU), a voluntary organization that seeks to ensure that the Kaka'ako Community Development District (District) be planned and developed to support a livable and quality community.

We appreciate the Authority's efforts to seek a solution to the management of our Kaka'ako parks, particularly upkeeping the cleanliness of the parks and ensuring the safety and security of park users. Our Neighborhood Watch Citizen Patrol walks have cited the problems and we have seen improvements but see the need for enforcement which now requires better coordination between the state's sheriff's department and the city's police department.

We thus support the transfer of management and enforcement for park safety, security and cleanliness to the City & County of Honolulu, as they have the staff and equipment to manage and enforce. However, we are very concerned with the City's recent actions relating to Thomas Square and Ala Moana Park. We believe that the public interest was not served; and it took the public protest for the city to reverse its development plans for the "people's park." We don't want to see this happening to our Kaka'ako parks for which we have plans, based on public input, and want reassurances that the Authority will retain control to ensure implementation of the planned uses and development of the park parcels.

We therefore ask that the Authority specify clearly that the transfer of the parcels be for purposes of management and enforcement of rules to ensure cleanliness, security and safety for the public parks; and that the Authority will retain control over zoning and permitting of any uses and development of the parcels, which have been approved after proper public notice and hearing in accordance with its rules.
