Planning and Development Activities

- Construction of the Enterprise Energy Corridor continues to be on schedule and the
 micro-tunneling activities began this month. Contractors are anticipating completion
 in three months. Upon completion, the conduit would be available for new electrical
 and telecommunication services along the corridor and subject to a connection fee
 from the respective utility company for new service.
- Construction of the Hawaii Army National Guard (HIARNG) Phase II of the 29th
 Infantry Brigade Readiness Center in Kalaeloa was delayed. Activities are expected
 to begin this month. The center houses the HIARNG's administrative and logical
 support under one roof, which enhances the brigade's readiness to respond to
 overseas or domestic operations. The 55,000-square foot building will include an
 auditorium, assembly hall, administrative spaces, storage vaults, locker rooms,
 information technology services and classrooms.
- The Department of Hawaiian Home Lands (DHHL) has received six qualified applicants to its public notice for solar or other renewable energy projects on four of its Kalaeloa parcels. The DHHL anticipates over \$100 million to be invested in these projects.
- On September 11, 2018, HCDA met with, Guernsey, regarding the Kalaeloa Safe and Reliable Energy Infrastructure Project. Also participating in the meeting were Navy staff that provided information about the status of their electrical grid feasibility study and the potential for a lease-to-fee option for third party provider. Guernsey is finalizing their projections and recommendation for the "Model of Energy—as-a-Service," which is a deviation from the traditional power purchase agreement model.
