II. Asset/Land/Property Management

A. Kakaako Waterfront Park/Kakaako Makai Gateway Park/Kewalo Basin Park

- 1. The HCDA continues to work with the City and County of Honolulu Department of Parks and Recreation to manage the parks and permit future events. In January 2019, the HCDA permitted two events. La-Vida Bridal received an annual permit for wedding photography, and St. Frances of Hawaii conducted a fun walk event in honor of St. Marianne Cope. Per City guidelines, only alcohol-free, non-commercial events held by non-profit organizations are currently allowed at the Kakaako Makai parks.
- 2. Three vehicles were towed for violating parking rules in December 2018 and January 2019. Two vehicles were towed from Kakaako Waterfront Park and one from Kewalo Basin Park.

B. Reserved Housing

- 1. In January 2019, one subordination request was approved to allow a unit owner to refinance an existing mortgage on their reserved housing unit. Another subordination approval is currently pending legal review.
- 2. In January 2019, there was one request to sell a reserved housing unit during its regulated term, thereby prompting the first option to purchase by HCDA. HCDA notified the unit owner of the purchase price, and the unit owner now has the option to proceed with selling their unit to the HCDA or withdrawing their request.
- 3. In January 2019, two Releases of Unilateral Agreement were executed. This allows reserved housing unit owner to pay off the shared equity due to HCDA upon the sale of a unit outside the regulated term.
- 4. In January 2019, there were eleven inquiries relating to Reserved Housing Rules and Regulations.

C. Right of Entry Agreements

There were 11 active Right of Entry agreements through January 2019. See Exhibit A.
