New Aloha Stadium Entertainment District (NASED)

The construction of the new stadium facility and ancillary development of the entertainment district surrounding the new stadium will be pursued under a Public-Private-Partnership between the state and a private developer selected through a State Procurement Request for Qualifications (RFQ)/ Request for Proposals (RFP) process.

Crawford Architects, with WT Partnership and AHL, are leading the master planning and completion of a Programmatic Environmental Impact Statement on behalf of the State of Hawaii.

HCDA Board meetings this month

The Authority authorized the executive director to provide up to \$2,249,100 from the HCDA Public Facilities Dedication Funds for restoration of the Hawaii Community Development Authority Kakaako Parks and complete the transfer of the parks to the City and County of Honolulu.

Deputy Attorney General, Lori Sunakoda testified before the Authority, that she is a part of the team working on the transfer documents and that the transfer is expected to happen by October 24, if no unforeseen events get in the way of their progress.

Meanwhile, the HCDA continues to work with the City and County of Honolulu Department of Parks and Recreation to manage the parks. A Right of Entry with the City was executed in August. The Kalaeloa meeting was cancelled.

The next HCDA Board meetings will be held on October 2, 2019. Board agendas are posted on the website the Thursday before meetings.
