## Report of the Executive Director KALAELOA

February 5, 2020

#### **Asset Management**

Kalaeloa Heritage Park

HCDA staff received the KHLF report in January, see it attached as Exhibit A.

#### Stockpile

On Tuesday, January 21, 2020, Henry's Trucking (Henry's) began the removal of the stockpile. Henry's anticipates the work will take four weeks. The required Department of Health (DOH) information has been submitted. Henry's will look for opportunities to divert materials to nearby recycling facilities located in Campbell Industrial Park to help reduce hauling charges. Staff reminded the contractor that DOH and HCDA requires a full accounting of the disposition of the materials.

#### **Engineering**

Contractor Paul's Electric is currently trenching and installing duct lines in Enterprise Street, up to Yorktown Street as they work toward Midway Street. There is also some work on Midway that needs to be done. Most of the manholes, except for the ones in Midway, have been installed. Contract completion is anticipated on or before February 29, 2020.





#### **Planning**

On January 22, 2020, the Kalaeloa Plan and Rules Update Task Force finalized the professional service consultants contracts, set the roles, responsibilities, and timeline for the process.

On January 23, 2020, HCDA staff met with the Kalaeloa Stakeholders and provided an update of the Kalaeloa district projects. HCDA staff requested future participation in the Kalaeloa Plan and Rules Update process. In addition, staff from ASEF II, Paul's Electric, and HK Management provided status on their projects. All participants also provided updates about their programs. The stakeholder group also set their goals and meeting times for 2020 as they are committed to the planning and development of Kalaeloa.

- ASEF staff reported construction is 90% complete and testing with Hawaiian Electric Company (HECO) has begun. ASEF anticipates hosting a project dedication in early March.
- Paul's Electric anticipates phase II of the Enterprise Energy Corridor project will be completed by the middle of March. The restoration of the Enterprise Avenue will be completed by the middle of April.
- HK Management presented the Honokea Surf Village project and the due diligence timeline. Stakeholders asked questions about the water usage, potential climate change impact and requested to build partnerships with the surrounding schools and small businesses.
- The Federal and State Shelter staff expressed the need for stakeholder support to request legislative support for building the HECO standard line extensions from the Enterprise Energy Corridor project to their buildings. Shelter stakeholders are requesting to put together a taskforce to specifically discuss electrical planning for their holdings to prepare for the 2021 legislative session. HCDA staff will participate.
