Planning

Kalaeloa Plan and Rules Update

Tori Gallas+Partners (TG+P) provided the Hawaii Community Development Authority (HCDA) staff with an overview of Kalaeloa Master Plan (KMP) draft updates for internal staff discussion regarding land use, infrastructure, and the City and County of Honolulu's (CCH) Complete Streets Program. Staff will conduct additional discussions with TG+P once the potential KMP streets concepts can be vetted with CCH staff.

Kalaeloa Stakeholders Meeting

Staff held the Kalaeloa stakeholders meeting virtually on Thursday August 12, 2021 and provided an update of the projects in the district. The Gentry Kalaeloa Team provided a project presentation for over 35 stakeholders and organizations that participated that day.

The next meeting is scheduled for Thursday, September 9, 2021.

Department of Transportation (DOT) Kalaeloa Airports (DOT-A)

DOT-A, Navy Facilities Hawaii, and HCDA staff met to discuss the plans for connecting DOT-A tenants to temporary electrical power. DOT-A also committed to finalizing the plans to convert over to Hawaiian Electric Company (HECO) power permanently from the Enterprise Corridor project.

United States Coast Guard (USCG)

USCG staff reported on the Coral Sea Road HECO extension power project. State DOT roadway contractors repaved the Coral Sea Road which caused some disruption in the USCG project. Construction has resumed and the project is still on track to be completed by Summer of 2022.

Navy Kalaeloa Electrical Charette

HCDA staff participated in the Navy's Electrical Charette on August 16th and 17th. The goal of the charette is to develop an electrical plan that will bring the Navy closer to divestment of the current antiquated electrical system and plan the details for transitioning the remaining customers over to a new HECO standard system.

Kalaeloa Assessments FY 2020-2021

HCDA staff mailed Kalaeloa assessments packets the second week of March for FY 2020-2021. The Authority approved the Kalaeloa assessments budget for \$570,500.00 and we have received \$320,229.00 thus far. HCDA received payments from fifteen of the eighteen landowners/users who were billed (DOT & HCDA are exempt). Staff is doing more research regarding the ownership of the Kapolei Infrastructure entity.

Kalaeloa Assessments FY 2021-2022

The Authority approved the FY 2021-2022 Kalaeloa assessments budget for \$572,315.00 and packets were mailed to the landowner/user at the end of July. The status of payments is included below:




Figure 1 - TMK 9-1-013069 Inventory Map




Figure 2 - Cultural and History Sites by TMK
