### Report of the Executive Director KALAELOA

November 3, 2021

#### **Planning**

Kalaeloa Plan and Rules Update

Tori Gallas+Partners (TG+P) provided the Hawaii Community Development Authority (HCDA) permitted interaction group (PIG) and staff with an overview of the Kalaeloa Master Plan (KMP) draft updates. HCDA staff will be meet with the City and County of Honolulu (CCH) Department of Transportation Services Complete Streets Team. The PIG plans to have follow-up discussions re residential unit count and the CCH's complete street and light industrial land use.

#### Kalaeloa Stakeholders Meeting

HCDA staff held the Kalaeloa Stakeholder's Group (KSG) meeting virtually on Thursday, October 14, 2021. HCDA staff provided an update of projects in the district. Kalaeloa Home Lands Solar Project and Hunt staff fielded questions regarding its projects. Cynthia Rezentes, Onelauena and Onemalu Homeless shelter board member, shared a PowerPoint presentation regarding the Community Based Renewable Energy program that she presented at the Public Utilities Community (PUC) meeting. The staff for the Barbers Point Solar Project (BPSP) announced consultation meetings will be held regarding the draft environmental assessment.

The KSG identified the following concerns:

- The Enterprise Avenue median strip is overgrown and causing safety concerns for students and pedestrians walking to school and the bus stops on Franklin D. Roosevelt Avenue; and
- Conditions are unsafe with construction steel plates at the Enterprise and Fort Barrette Avenues intersection. HCDA staff contacted Paul's Electrical construction staff who is conducting roadway work on Fort Barrette and Enterprise Avenue on Friday, October 15, 2021, to address the issue.

The November meeting is being skipped due to the Veteran's Holiday. The next meeting will be held on Thursday, December 9, 2021.

#### Navy Kalaeloa Divestiture Team

HCDA staff participated in the Navy's Kalaeloa Divestiture Team discussions on October 14, 2021. Hawaiian Electric Company (HECO) confirmed the new Enterprise Avenue duct line system and associated 12kV UG circuits, are now installed and energized all the way down Enterprise Avenue to Midway Road. HECO staff anticipates additional electrical work along Midway Road between the cross street of Hancock Street and Lexington Avenue. The United States Navy (Navy) announced that a notification letter will be sent out to the 9 landowners currently on the Navy's system.

Kalaeloa Assessments FY 2020-2022

The HCDA approved the FY 21-22 Kalaeloa assessments budget for \$572,315.00. The payment status table is included below: **No change from last month's report.**




Figure 1 - TMK 9-1-013069 Inventory Map




Figure 2 - Cultural and History Sites by TMK
