## **Report of the Executive Director - Kalaeloa**

September 7, 2022

#### I. Planning & Development

#### Kalaeloa Plan and Rules Update

On July 29<sup>th</sup>, Torti Gallas+Partners ("TG+P") presented the HCDA Permitted Interaction Group ("P.I.G.") with the comments received on the Administrative Draft of the Kalaeloa Community Development District Master Plan. All comments from the HCDA P.I.G., other government agencies, organizations and the public were grouped by topic and synthesized for consideration. The P.I.G. advised HCDA staff and TG+P how to address the various issues and inquiries, and these changes have been incorporated into the Draft. The latest version of the "Draft Master Plan," will be presented to the Board on September 7, 2022.

#### Honokea Surf Village

On August 3<sup>rd</sup>, the Board received an informational update from HCDA staff as well as the Applicant's consultant for the Honokea Surf Village project, which is proposed for the 19.4-acre parcel located off Coral Sea Road and owned by HCDA. The application is forthcoming once SHPD concurrence is granted, and the request will be processed as a development permit application through a contested case process. Since the August 3, 2022, Board meeting, the Applicant has worked to prepare a submittal package for review by the Kalaeloa Design Advisory Board.

#### Kalaeloa Assessments

On August 3<sup>rd</sup>, the Board voted to approve the FY22-23 budget for the Kalaeloa Community Development District ("KCDD"). Currently, the HCDA staff is working on the landowner letters and invoices.

#### Gentry Ka'ulu

On August 3<sup>rd</sup>, the Board voted to approve the Reserved Housing ("RH") Program for Gentry's Ka'ulu development. The RH Program will be implemented in multiple phases over three years. Gentry will come back to the Board for approval of pricing prior to sales of RH units for each phase.




Figure 1 - TMK 9-1-013069 Inventory Map




Figure 2 - Cultural and History Sites by TMK
