### Kalaeloa Plan and Rules Update

The Kalaeloa Permitted Interaction Group has reviewed the first draft of the update to the 2012 Kalaeloa Community Development District Rules, Chapter 15-215, Hawaii Administrative Rules ("HAR"). The HCDA's consultant, Torti Gallas+Partners, is incorporating the comments received from the Permitted Interaction Group into the draft rule amendments that will be presented to the Board and the community in June.

Honokea Surf Village: Environmental Assessment and Finding of No Significant Impact The public challenge period for the Second Final Environmental Assessment and Finding of No Significant Impact (FEA-FONSI) for the Honokea Surf Village Project concluded on April 24, 2023. HCDA staff are aware of one complaint that was filed with the First Circuit Environmental Court. The applicant is negotiating with the HCDA on the terms of a ground lease for the 19.4-acre site and will also submit applications for a Development Permit and Conditional Use Permit once the State Historic Preservation Division concurrence is received. In April, the applicant also presented a project update to the Oahu Island Burial Council and received approval of the general approach for the treatment of possible burial sites.
