

#### **UPDATE:**

- HCDA to procure design-build contractor to complete identified infrastructure upgrades.
  - HCDA RFP to be issued end of Q3 2023



 Infrastructure upgrades to support the development of a projected 6,236 new housing units in the next 10



## East Kapolei

Infrastructure Planning & EIS

#### FY 23-24

- \$2 million Infrastructure implementation master plan and programmatic environmental impact statement (EIS).
- In collaboration with the Office of Planning & Sustainable Development (OPSD).

## East Kapolei

Infrastructure Planning & EIS

- HCDA is preparing to transfer the funding and project management for the project to OPSD.
- OPSD is reviewing agreements between the relevant state agencies and the City to outline roles and responsibilities.
- An RFP to secure consultant planning services has been drafted. With the expected budget reduction to \$500,000, OPSD will focus on delivering the infrastructure master plan, and defer the Environmental Impact Statement tasks until additional funding is available.

#### UH West O'ahu

#### On-site Infrastructure

#### FY 23-24

- \$35 million On-site infrastructure for twentyacre parcel.
- Infrastructure to support the development of affordable housing and the University Village.
- In collaboration with the Hawai'i Housing Finance & Development Corporation (HHFDC), and the University of Hawaii (UH).

#### UH West O'ahu

On-site Infrastructure


- HCDA to draft MOU with HHFDC, and UH.
- HHFDC will issue an RFP for the development of a 20acre parcel, to include the development of a University Village, mixed use housing development, and leasehold for sale units.
  - HHFDC RFP to be issued Q4 2023
- HCDA to issue a design-build RFP for the construction of infrastructure and roadways to support the HHFDC developments.
  - HCDA RFP to be issued end of Q3 2023

#### Kalaeloa

#### Electrical Upgrades

#### FY 23-24

- \$5 million Electrical upgrades.
- \$12,125,000 Saratoga Avenue electrical upgrade.
- Upgrades to further efforts to transfer all customers off the Navy electrical utility system.
- In collaboration with the Hawaiian Electric Company (HECO), the Navy Facilities Engineering Systems Command (NAVFAC) Hawai'i, and private developers.

#### Kalaeloa

Electrical Upgrades

- HCDA to issue a design-build RFP for the \$12,125,000 –
   Saratoga Avenue electrical undergrounding work.
  - HCDA RFP to be issued end of Q3 2023



#### Kalaeloa

Electrical Upgrades

- HCDA to utilize the \$5 million, electrical upgrade funding, to address potential construction overruns on Saratoga Ave., and environmental assessments for electrical undergrounding work.
- Ongoing collaboration efforts with the HECO, NAVFAC Hawai'i, and private developers to determine the phasing and future projected electrical loads for the district.
