






Kaka'ako Community Development District History


A BILL FOR AN ACT

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 206E, Hawaii Revised Statutes, is amended by adding a new section to part II to be appropriately designated and to read as follows: "\$206E- Prohibitions. Anything contained in this chapter to the contrary notwithstanding, the authority is prohibited from: (1) Selling or otherwise assigning the fee simple interest in any lands in the Kakaako community development district to which the authority in its corporate capacity holds title, except with respect to: Utility easements; Remnants as defined in section 171-52; 13 Grants to any state or county department or agency; or (D) Private entities for purposes of any easement, 15 roadway, or infrastructure improvements;

- Act 317 superseded 2005
 Makai Area Rules, but
 which still remain in effect
- Residential uses are technically still allowed



Kaka'ako Makai Conceptual Master Plan

- Kaka'ako Community Planning Advisory Council (CPAC) was established in 2006
- Community representatives included the Native Hawaiian community, the Office of Hawaiian Affairs, and the Friends of Kewalo Basin Park Association
- Developed and codified 14 guiding principles and the 2011 conceptual master plan

Planned Amendments

- Conform to Act 317 (no residential development)
- Incorporate the adopted
 2011 Conceptual Master Plan
- Permit simplification
 - Based on mauka permit framework (improvement, renovation permits)
 - Simplified zoning

- HCDA Board approval to proceed into the formal public hearing process
- Formal Public Hearing
- Decision-making hearing
- Governor sign-off
