#### Wednesday, February 1, 2023

#### **MINUTES**

## I. <u>CALL TO ORDER/ROLL CALL</u>

The Hawaii Community Development Authority ("Authority" or "Board"), a body corporate and a public instrumentality of the State of Hawaii, met virtually (utilizing the state-supported Zoom Meeting platform) for a Regular meeting on February 1, 2023.

Chairperson Chason Ishii called the February 1, 2023, HCDA Kakaako Authority Regular meeting to order at 10:01 a.m.

#### Acknowledgement that the Meeting is Being Convened Virtually

Executive Director Craig Nakamoto reiterated the wording contained in the Meeting Agenda regarding the guidelines and directives provided by Section 92-3.7, Hawaii Revised Statutes, to enable public boards and commissions to conduct business virtually with a meeting site open to the public.

## II. APPROVAL OF MINUTES

Regular Meeting Minutes of January 4, 2023

## III. <u>DECISION MAKING</u>

Consider Adopting Hearing Officer Wayne Nasser's Recommended Findings of Fact, Conclusions of Law and Decision and Order in the Following Consolidated Contested Case Hearing Matter: Docket No. ACC-2017-01 in Re Petition of the Golden Eagle Marine Charter Services Corp.

The Authority may convene in executive session pursuant to HRS §92-5(a)(4) to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities and liabilities.

Chair Ishii provided an overview of this matter. Chair Ishii asked Executive Director Nakamoto if the parties were able to settle this matter in mediation since the Authority's last meeting, January 4, 2023.

Executive Director Nakamoto stated the parties have not entered mediation and have not been able to settle this matter.

Chair Ishii polled the board members to affirm that those participating in decision making have reviewed the record, the hearing officer's recommended Findings of Fact, Conclusions of Law, and Decision and Order, and were either present, or reviewed, the arguments made by the Petitioner's counsel and Respondent's counsel during the January 4, 2023, Kakaako Authority meeting.

Chair Ishii, Vice Chair Apo, and Members Higa, Miranda-Johnson, Hirai, Evans, and Sakoda affirmed. Member Nasir did not affirm and stated she will abstain from voting.
