## **II.** Asset/Land/Property Management

- A. The Kalaeloa Heritage and Legacy Foundation (KHLF) monthly reports for March - April 2025 are attached (See Exhibit A). An updated site inventory report and diagram following the annual site inventory is also attached (see Exhibit B).
- B. Kalaeloa Board members previously inquired about whether KHLF eradicates chickens at the Kalaeloa Heritage Park. KHLF's feral animal management plan, which was prepared as a condition to their lease in November 2023, is attached as Exhibit C. It notes that in the event the number of feral animals exceeds 10 chickens or 5 peacocks, KHLF will humanely trap at least 50% of the animals and take them to the Hawaiian Humane Society. So far, the number of feral animals has not risen to this level, as KHLF staff refrain from feeding them.
- C. Kalaeloa Board members previously inquired about whether KHLF is impacted by federal funding freezes. KHLF notes the only Federal grant they had been pursuing was a REPI grant (U.S. Department of Defense Readiness and Environmental Protection Integration Program). This grant is not integral to KHLF operations but would fund the clearing of kiawe and other invasives at the Kalaeloa Heritage Park. That grant is currently in limbo, although KHLF has been assured that the project is moving forward.

- D. On February 28, 2025, Kanoa Winds LLC installed a vertical wind turbine at the edge of the Kalaeloa Heritage Park maintenance yard. The turbine technology known as the Vertical Coaxial Contra-Rotating Twin Blades (VCCT) wind turbine has been used throughout Japan for more than 15 years. The installation at KHP features a 0.3 kW VCCT unit that will allow Kanoa Winds to conduct an in-depth study of its wind speed power generation, equipment load, stability tests, safety evaluation, wildlife impact, and environmental assessment. The wind turbine is equipped with batteries and can power small electronics and lights to assist KHP operations.
- E. Right of Entry Agreements: There were two (2) active Right-of-Entry (ROE) agreements through May 2025 (See Exhibit D).




Figure 1 - TMK 9-1-013069 Inventory Map




Figure 2 - Cultural and History Sites by TMK

## Background

Prior to February 2020, staff at the Kalaeloa Heritage Park (Park) provided feed to the freerange/feral chickens and peacocks at the Park as a means to keep the animals onsite to assist with the control of pests (e.g., biting insects, worms, slugs, etc.).

The Right of Entry (ROE) agreement between the Kalaeloa Heritage and Legacy Foundation (KHLF) and the Hawai'i Community Development Authority (HCDA) includes Exhibit C, which lists a number of required milestones. Milestone 2 requires the development of a management plan specifying how the population of free-range/feral animals (i.e., chickens and peacocks) is being managed by the KHLF to ensure that the premises is not damaged or adversely impacted.

After a discussion regarding animal control at the 05 February HCDA Board meeting, KHLF immediately directed Park staff to discontinue the manual feeding practice.

## Research

In order to develop an informed, standards-based model for its feral animal management plan, the KHLF contacted the following organizations for guidance:

1. Hawai'i Invasive Species Council (HISC), Department of Land and Natural Resources (DLNR)

Joshua Atwood, HISC Program Supervisor, advised that chickens and peacocks are not officially considered an invasive species. Mr. Atwood suggested that a nuisance wildlife control permit could be requested from the Department of Forestry and Wildlife.

2. Vector Control Branch, Department of Health (DOH)

Michael Carberry, Inspection & Abatement Section Supervisor, advised that Vector Control would only become involved if the animals became a public health issue (i.e., animals transmitting sickness to humans, etc.). He recommended that the KHLF continue to naturally control the population of the animals by not feeding them. He also suggested that if the situation worsens, trapping the animals and turning them over to the Hawaiian Humane Society for action would be the best, most humane, alternative.

3. Hawaiian Humane Society

The Hawaiian Humane Society advised that they are equipped to accept any stray animals. The fee to surrender an owned animal is \$35.00 apiece. Since the KHLF does not own these feral animals it is expected that there would be no cost to surrender these

animals. The Hawaiian Humane Society's Admissions Department contact number is (808) 356-2285.

## Management Plan

Based on the guidance from the HISC, Vector Control, and Humane Society, the KHLF provides the following management plan:

- 1. Park staff will discontinue all manual feeding of the chickens and peacocks
- 2. Park staff will continue to log the monthly population of chickens and peacocks
- 3. KHLF will include the feral animal population count as part of its monthly report to HCDA
- In the unlikely event that the number of feral animals exceeds ten (10) chickens or five (5) peacocks, Park staff will humanely trap at least 50% of those animals. The live animals will then be surrendered to the Hawaiian Humane Society.

KHLF believes that the ongoing process of denying feed to these animals will allow natural attrition; which will result in the animals instinctively adjusting their numbers to reach a state of equilibrium with respect to their population and the natural carrying capacity of the Park.

KHLF has already determined that this practice has resulted in the decline of the population of chickens and peacocks at the Park. As of July 2020, there were five (5) chickens and two (2) peacocks observed at the Park. This is down from the January 2020 count of seven (7) chickens and three (3) peacocks.
