A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii housing finance and development
2 corporation shall institute proceedings for the condemnation of
3 the ground lease for the Front Street Apartments affordable
4 housing project pursuant to chapter 101, Hawaii Revised
5 Statutes.

6 SECTION 2. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$250,000 or so much
8 thereof as may be necessary for fiscal year 2018-2019 for an
9 appraisal and other preparations for instituting the
10 condemnation proceedings under section 1; provided that no funds
11 authorized pursuant to this section shall be made available
12 unless the county of Maui provides dollar-for-dollar matching
13 funds.

14 The sum appropriated shall be expended by the Hawaii
15 housing finance and development corporation for the purposes of
16 this section.

17 SECTION 3. There is appropriated out of the rental housing
18 revolving fund the sum of \$30,000,000 or so much thereof as may



1 be necessary for fiscal year 2018-2019 to expedite and complete
2 the construction of the Leialii affordable housing project in
3 Lahaina, Maui, by 2021.

4 The sum appropriated shall be expended by the Hawaii
5 housing finance and development corporation for the purposes of
6 this section.

7 SECTION 4. This Act shall take effect on July 1, 2018.

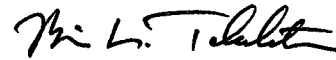

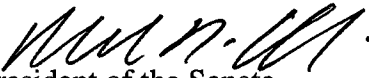
