

NOTICE OF PUBLIC HEARING
(for consultation on housing needs)

Pursuant to 24 CFR Part 91, notice is hereby given that the Hawaii Housing Finance and Development Corporation (HHFDC), Department of Business, Economic Development and Tourism, State of Hawaii, will hold public hearings on the housing needs to be considered in the State Consolidated Plan (CP) for Program Years 2020 – 2024 covering the period from July 1, 2020 through June 30, 2025, and the Annual Action Plan (AAP) for Program Year 2020-2021. Public hearings will be held on the following dates:

- Wednesday, September 11, 2019 at 10:00 a.m. at the County of Hawaii's West Hawaii Civic Center, Mayor's Conference Room, 2nd Floor, 74-5044 Ane Keohokalole Highway, Kailua-Kona, Hawaii;
- Friday, September 13, 2019 at 10:00 a.m. at the County of Hawaii's Office of Housing and Community Development, Existing Housing Conference Room, 1990 Kinoole Street, Hilo, Hawaii;
- Monday, September 16, 2019 at 9:30 a.m. at the City and County of Honolulu's Mission Memorial Building Hearings Room, 550 South King Street, Honolulu, Oahu;
- Tuesday, September 17, 2019 at 9:00 a.m. at the Mayor's Conference Room, 200 South High Street, Kalana o Maui Building, 9th Floor, Wailuku, Maui; and
- Tuesday, November 12, 2019 at 4:30 p.m. at the Pi'ikoi Building, 4444 Rice Street, Pi'ikoi Conference Room A, Lihue, Kauai.

The CP and AAP describe the State's housing needs, funding plans, and certified program compliance with the CP, HOME Investment Partnerships (HOME), National Housing Trust Fund (HTF), Emergency Shelter Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) programs. These HUD programs provide funding to expand the supply of affordable housing for low- and moderate-income families, restrict increases in homelessness, and provide preventative programs and activities for the homeless in the State.

The CP's and AAP's purpose is to ensure that jurisdictions receiving federal assistance plan for the housing and related needs of low- and moderate-income families in a way that improves the availability and affordability of decent, safe, and sanitary housing in suitable living environments. To receive funding under certain U.S. Department of Housing and Urban Development (HUD) programs, the State must have a housing strategy that has been approved by HUD. For Program Year 2020-2021, the State of Hawaii anticipates receiving approximately \$3,000,000 in HOME funds, \$3,000,000 in HTF funds, \$400,000 in ESG funds, and \$200,000 in HOPWA funds.
