## STATE OF HAWAII HAWAII HOUSING FINANCE AND DEVELOPMENT CORPORATION SUBSTANTIAL AMENDMENT NO. 4 TO THE PY2018 ANNUAL ACTION PLAN

In its PY2018 Annual Action Plan (AAP), approved by HUD in August 2018 and amended in February 2019, May 2019, and April 2020, the Hawaii Housing Finance and Development Corporation (HHFDC) reported that the City and County of Honolulu (City) would be utilizing a portion of its PY2018 National Housing Trust Fund (HTF) program funds for two workforce housing projects serving special needs populations. The City was unsuccessful in utilizing the HTF funds, and subsequently returned its PY2018 HTF funds to HHFDC for re-allocation. In accordance with HHFDC's PY2018 HTF allocation plan, HHFDC sought alternate activities from the remaining Subgrantees (the Counties of Hawaii, Kauai and Maui). On May 29, 2020, HHFDC identified the County of Kauai to receive \$1,350,000 for its Pua Loke Affordable Housing project in Lihue and \$75,000 for the County of Kauai's administration of HTF program activities.

The Pua Loke project is an affordable multi-family housing development for households earning 100% or less of the area median income. The County of Kauai previously awarded its PY2019 HTF funds to the project, which was to have produced a total of 50 units and four HTF-assisted units. Including the PY2018 HTF funds, the project will consist of 54 total units, nine of which will e HTF-assisted units serving households with incomes at or below 30% of the area median income.

This Substantial Amendment No. 4 to the PY2018 AAP identifies the County of Kauai to receive additional HTF funds of \$1,425,000 for its Pua Loke project and administration of the HTF program and incorporates the funds and activities into the PY2018 AAP. Other aspects of the PY2018 AAP will remain the same.

On June 5, 2020, a Notice of Public Comment (Notice) was published in the Honolulu Star-Advertiser and posted to HHFDC's website at <a href="http://hawaii.gov/dbedt/hhfdc">http://hawaii.gov/dbedt/hhfdc</a>, inviting the public to comment on the proposed amendment to the PY2018 AAP. The Notice and Draft Substantial Amendment No. 4 to the PY2018 AAP were also sent to depository libraries and posted to HHFDC's website. HHFDC utilized a HUD-authorized waiver to the 30-day public comment period, in favor of a five-day comment period, to allow an immediate use of HUD funds in communities affected by COVID-19. No comments were received.

## NOTICE OF PUBLIC COMMENT On Draft Substantial Amendment No. 4 to the PY2018 Annual Action Plan

Pursuant to 24 CFR Part 91, the Hawaii Housing Finance and Development Corporation (HHFDC), Department of Business, Economic Development and Tourism, State of Hawaii, gives notice that a draft Substantial Amendment No. 4 to the Consolidated Plan Annual Action Plan (AAP) for program year July 1, 2018 – June 30, 2019 (PY2018) has been prepared. The HHFDC is making the document available for review and comment.

The purpose of the Consolidated Plan and the AAP is to ensure that jurisdictions receiving federal assistance plan for the housing and related needs of low- and moderate-income families in a way that improves the availability and affordability of decent, safe, and sanitary housing in suitable living environments. To receive funding under certain U. S. Department of Housing and Urban Development (HUD) programs, the State must have a housing strategy that has been approved by HUD.

The HHFDC administers HUD's National Housing Trust Fund (HTF) program and gives notice of a draft Substantial Amendment No. 4 to its PY2018 AAP to identify and incorporate an eligible activity to be supported with PY2018 HTF funds. The County of Kauai, as HHFDC's Subgrantee of HTF funds, intends to utilize HTF funds in the Pua Loke Affordable Housing Development project in Lihue. The Pua Loke project will consist of 54 total units, nine of which will be HTF-assisted and serve extremely low-income households with incomes at or below 30% AMI.

The draft Substantial Amendment No. 4 to the PY2018 AAP is available for public review on HHFDC's website at <a href="http://hawaii.gov/dbedt/hhfdc">http://hawaii.gov/dbedt/hhfdc</a>. Due to health and safety concerns caused by COVID-19, state and county housing agencies, where draft amendments would normally be available for public viewing, are taking precautionary measures by closing their offices to the public.
