Report to the 2024 Hawai'i State Legislature:

Section 201H-206, Hawai'i Revised Statutes, requires the Hawaii Housing Finance and Development Corporation (HHFDC) to "submit a report to the legislature no later than twenty days prior to the convening of each regular session describing the projects funded using moneys from the affordable homeownership revolving fund." This report satisfies that requirement.

To date, the Affordable Homeownership Revolving Fund (AHRF) has not funded any projects.

Act 227, Session Laws of Hawai'i (SLH) 2021, appropriated \$1,000,000 of American Rescue Plan Act funds that were not released by the Department of Budget and Finance and lapsed pursuant to Act 314, SLH 2022. The Supplemental Appropriations Act of 2022 appropriated \$5,000,000 of general funds for the purposes of the program. Act 93, SLH 2023 clarified that those funds are to be deposited into and expended from AHRF, where program loans can revolve after being repaid in order to fund future loans. Proposed administrative rules for the AHRF Program failed to get the support of the community at the public hearing on the rules held in November 2022. Revised proposed rules were met with community support at a public hearing held in October 2023. The Governor signed the administrative rules on November 17, 2023, and they became effective ten days later.

HHFDC anticipates making its first AHRF Program awards in Summer 2024.
